ACADEMIC SENATE, BAKERSFIELD COLLEGE: RESOLUTION NO. 2

Re: AB 705 - Unfunded and Costly Mandate

Whereas: AB 705 language indicates compensation for costs incurred by this statutory provision must be reimbursed to the community college districts;

Whereas: The California state legislature was incorrectly informed AB 705 would be a zero sum statute wherein savings from reducing basic skills courses would equally translate into funds appropriated for the necessary expenses for increase in transfer level courses in math and English;

Whereas: The implementation of AB 705 has not been a zero sum statute as districts have had to maintain necessary coursework for local awards and part-time students, as well as provide the CCCCO proposed co-requisite classes in math and English;

Whereas: the default guidelines support large numbers of students will fail transfer level coursework in math and English and thus need additional support or coursework to get back on track;

Whereas: The reallocation of funds from certain disciplines and certain courses will eventually negatively impact hiring and ultimately support for degree completion in other disciplines, eroding the institution's ability to provide a holistic educational environment;

Be It Resolved: The Academic Senate for California Community Colleges collect and analyze costs pursuant to AB 705 and report these costs to the Legislative Analyst's Office, to the California state Legislature and to the California Community Colleges at large.

AB 705 "To the extent the bill would impose additional duties on community college districts and colleges, the bill would impose a state-mandated local program.

(2) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

The Cost of Implementing Multiple Measures and Concerns for AB 705 Implementation at Bakersfield College

Bakersfield College began implementing multiple measures I 2014-15 with a small cohort of 500, that grew to 1500 (2015-16), then all first time in college students (FTIC) (2016-17), and to all student in 2017-18 using the MAPP 2.0 tested and data supported placement rules with 2.6 as the HSGPA for transfer English and Math classes at about the same GPA but more complicated due to the many different math courses.

Beginning with Summer 2018, the college implemented the default placement rules to the FTIC. The cost of this gradual implementation was not neutral. In other words, the replacing of remedial English courses with transfer-level courses was not a simple trade out. In fact, the number of English 1A course sections increased very rapidly (see data below)

There were inadequate faculty and inadequate classroom space to support this growth, so additional online course sections were started to accommodate students. Although more faculty were hired, the majority of the increase required additional adjunct faculty. This increase, at is most conservative expense considering the cost per faculty per section at \$6000 the adjunct wage

Since then with AB 705 implementation for FTIC effective Summer 2018

With the implementation of AB 705 this summer applied to First Time Students the number of transfer level English sections increased again to accommodate an additional 167 FTIC students or approximately 6.5 sections. Fall 2018 is currently hosting 182 sections (which was only 117 sections in 2017-18) an additional 65 sections. In addition, the AB 705 guidelines suggest concurrent support. These supports are often 2-3 units in English which increases the cost yet again by 66 to 100% and requires additional space and faculty.

These sections have not been created by replacing the courses still required by Ed. Code and AB 705 to meet the needs of non-transfer students. Bakersfield College was able to gradually increase the sections and support for transfer level English over 4 years. AB 705 does not allow those accommodations as implementation is required by Fall 2019. This cost is unsustainable for small colleges and the colleges around the state who have seen flat or declining student enrollments.

AB 705 is not a miracle drug. The default placement rules predict many students will fail. What will happen to them? Will they take a lower class to get the skills or attempt another time at transfer level. In either case these students will add to the additional class sections needed.
