A. [Constitution/Bylaws](#) (Duties of Senators in Constitution Article V, Sec. 5)

As the new Academic Senate President, N. Strobel reviewed the Constitution/Bylaws to better understand each members duties.

Responsibilities of Senators

a. A Senator shall attend all meetings of the Senate.

b. If a Senator misses three or more meetings of the Senate per year, she or he may be removed from office by a two-thirds vote of the Senate.

c. A Senator shall communicate business items and other concerns between her or his Discipline Area and the Senate.

Later this Fall these will be reviewed and brought forward to the Senate for clarification and potential changes in the Constitution/By-Laws revision.

C. [Brown Act \(Brown Act Cheat Sheet\)](#) 34:34

The Academic Senate is a Brown Act committee. The Brown Act is the open transparency law in California. Here are some highlights:

- Agendas need to be posted 72 hours ahead of time (by 3:30 on Sunday).
- Any item on the agenda that will be voted on has to be clearly labeled.
- There must be enough description in the agenda for the general public to be able to determine if they should attend the meeting. Descriptions should be no more than 20 words long.
- There is and agenda item request form on the Senate's website under the joining Academic Senate meetings section.
- There is a process for emergency situation additions after the 72 hour window. We would need two-thirds of the membership or a unanimous vote of those present at the meeting to agree to add it to the agenda.
- Outlines the time the general public is allowed to speak (this includes committee chairs). There will be a discussion about possibly increasing that time.
- In order to avoid illegal serial meetings is by not talking/emailing/texting/social media posting about agenda items to anyone from outside your department.
- Minutes should include any action taken and the vote on any action by each member present.
