EVALUATION OF ADJUNCTS

Adjuncts shall be evaluated their first semester at a college. Upon receiving a satisfactory rating on the first evaluation, an adjunct shall be evaluated in the third year and every three years thereafter. The adjunct evaluation form shall note ADJ-1 for first semester evaluations and ADJ-3 for all subsequent evaluations.

Dual Enrollment

Kern Community College District (KCCD) is a three-college district located in the Central Valley of California. The three colleges are Bakersfield College, Cerro Coso Community College, and Porterville College. All three colleges have established Dual Enrollment and Concurrent Enrollment programs for students to earn college credit while in high school. District policy allows each college to waive enrollment fees for high school students in these programs.

High school students taking college courses in KCCD have two options: (1) they can register for courses on a college campus, a satellite location, or online through Concurrent Enrollment or (2) they can be enrolled in courses that are offered on their high school campus through a Dual Enrollment partnership which is defined by an MOU Agreement between KCCD and the high school district. Some high school partners also offer tailored "Early College" programs for students to complete college credits, certificates, or degrees while in high school, but these programs vary by college, district, and high school.

Each college has slightly different definitions and processes for the programs that they have established for students to earn college credits, certificates, and/or degrees while in high school. To support program and enrollment growth across the district, the dual & concurrent enrollment transition teams were formed by each college and at the district office. Course Instructor Agreement

Whereas, _____ ("INSTRUCTOR") desires to teach a college course for the Kern Community College District (KCCD), and;

Whereas the KCCD desires that INSTRUCTOR teach a college course for KCCD as part of its dual enrollment program with the _____ (DISTRICT);

Therefore KCCD and INSTRUCTOR (collectively known as the PARTIES) agree as follows:

1. INSTRUCTOR shall at all times during the term of this agreement be an employee of DISTRICT.
2. INSTRUCTOR represents that it all times during the term of this agreement INSTRUCTOR shall meet the minimum qualifications for teaching a community college course as provided in 5 CCR 53400-53430 and applicable KCCD policy.
3. INSTRUCTOR is not an employee of KCCD.
4. INSTRUCTOR agrees that when INSTRUCTOR is providing instruction for a college course, KCCD shall have the primary right to control and direct the instructional activities of INSTRUCTOR. INSTRUCTOR shall be considered an employee of KCCD for the limited purpose of rendering instructional services under the terms of this agreement.

4. INSTRUCTOR agrees that when INSTRUCTOR is providing instruction for a college course, KCCD shall have the primary right to control and direct the instructional activities of INSTRUCTOR. INSTRUCTOR shall be considered an employee of KCCD for the limited purpose of rendering instructional services under the terms of this agreement.

5. INSTRUCTOR shall comply with all applicable policies and procedures of KCCD in rendering instructional services under this agreement. INSTRUCTOR shall also comply with all applicable state and federal statutes and regulations in rendering services under this agreement.

6. INSTRUCTOR understands and agrees that INSTRUCTOR's performance under this agreement shall be evaluated by KCCD as provided in California Education Code Section 87663 (a).

7. The Memorandum of Understanding for Dual Enrollment between KCCD and District ("MOU") is incorporated by reference as if fully set forth herein. In the event of a conflict between this agreement and the MOU the provisions of the MOU shall prevail.
