Description: Cerro Coso is offering dual enrollment courses in our service area. Concerns include lower min quals of high school instructors, lower standards in the classes, and lack of observation. This is a Discussion item.

This topic was discussed at length. The following concerns, questions and suggestions were shared:

- The process that was in place over the past ten years was to work between the Dual Enrollment “shop”, VPI and Department Chair as our first concern, keeping in mind partnering with the community.
- In the case of the Political Science class this process was deviated.
- It seems departments are not consulted about program building and rather that is being decided at the program manager level or at the district level.
- How do we ensure quality assurance aspects and what assessment instruments are being used?
- How are requirements evaluated and is there a review system in place?
- How do we manage quality control?
- Are we reviewing the syllabus content?
- Faculty are under loaded and looking for classes to fill their load, yet it was being offered at BHS as a DE class.
- High schools have more sections then they have instructors and cancelling them can negatively impact the funding.
- One department (Agriculture) has a designated Task Force Rep that is a paid liaison who organizes subject matters with instructors.
- It is suggested to put in place a process for vetting dual enrollment for each individual department – bring this up at your next department meeting.
- EMC & Assessment Committee to visit DE process.

President Dadabhoy addressed the Senate’s concerns and reassured the members that moving forward this sort of issue will be discussed collegially. Dr. Dadabhoy, encouraged members to work together through such issues alongside our constituent groups.
