
a. Chair, Matthew Frazer, President

Discussion:

President Frazer. I have the list of meetings finalized, and have been distributing them out to the committees and people who need them.

c. Setting up bi-monthly meetings with President Discussion: President Frazer: I have still not received any responses from officers or their managers on meeting with me, I would like to meet with you at least twice a month to stay up-to-date with what is happening. All I need is a time and a date, whether it's during lunch or before classes, I just need to meet with you so we can discuss and see what is happening outside of the executive meetings. I prefer to meet on Mondays, Wednesdays, and Fridays.

8. NEW BUSINESS

A. Discuss changing thanksgiving break to a week.

Discussion:

President Frazer: This ideas has been in the senate since last year, and involves changing the regular Thursday-Friday break to a whole week break for students. This normally would have to involve the students on campus, however due to low-feedback results, this will remain a senate decision. Theoretically, making the Thanksgiving break a week long break instead of two days would result in having to add a few extra days of class afterwards, but we need to take into consideration other programs such as the night-time classes, students have no one to watch their children and student drop rate rise significantly during this time.

Manager Manos: If we do this for the Thanksgiving break, would we be willing to look at the spring break as well, because there are a number of students who cannot continue because there is no one to look after their children.

President Frazer. We are mostly focusing on the Thanksgiving break because there is a more significant drop in students compared to the rest of the school year, however this could be looked at in the future.

Director Smith: I know of a few students who take night classes, and while this problem is prevalent, I personally don't think changing the break to a week would benefit the students because many are coming to college for the first time and experiencing a dynamic shift. Having a month long break in December is just one of these changes but it is probably one of the more positive ones, because in high school students are only given a week or two of break, here they have more time to relax and unwind after finals. In addition, there are more holidays celebrated during the week of December than November, so I don't believe extending the Thanksgiving break is a wise choice.

Dr. Damania: At the last institution I worked at, the day before the Thanksgiving break and the day after classes went on break, the school would enact a prep-day, where professors would be in their offices helping students with questions. If the Thanksgiving break is extended then we could possibly push for a prep-day of our own for students before finals.

President Frazer: Here at BC, we have finals two weeks after the end of Thanksgiving break. And while the time between finals and the end of Thanksgiving break differs year by year, if we decide to extend the break length, it could be implemented as early as next fall semester. We have till October to decide whether or not it will be approved. The Senate asking for our stance so that they can proceed with the process.

Dr. Damania: The most efficient way to do this is to write a resolution for senate to see and decide on, then rewrite the resolution and re-present it to the senate to make a final decision on. It must be sponsored by a senator to be presented.

B. Discuss having armed security on campus.

Discussion:

President Frazer. This is another items brought to me by the senate that concerns armed security on campus. There are two options for this: first is making a contract with the Bakersfield Police Department and having an officer on campus, the second is paying for the certification of our officers on campus to carry.

Manager Manos: Who would be chosen to carry firearms?

President Frazer: It would be a select few due to the certification process being expensive. Later today I will be going to an informational briefing to learn more, hopefully I will get back to you with more information.

Director Smith: My only worry with this is that, if the training is not adequate enough, a student could be mistaken for a threat and taken down.

President Frazer: The training is a state approved certification. Around most of the country, the number of instances between students and armed security is less than a percent, in fact, the percentage of threats on campuses has decreased once an armed officer comes on campus.

Manager Manos: I would like to see if there is a present need for an armed officer on campus, that way we can decided whether we need several trained security guards on campus or just a single BPD officer.

Dr. Damania: If it's possible, have representatives from different departments – Public Safety – present at the senate meeting where this resolution will be presented, that way you can get more feedback.
