**b.** BCSGA Advisor, *Dr. Damania* No report.



## 8. UNFINISHED BUSINESS

Items listed have already been discussed once and thus are considered for approval by the Body

a. Review of the: "Student Fee Handbook"

#### Discussion:

Director Zavala: We will be discussing a number of fees within the hand book, we will begin with the Student Center Fee. This allows the district to charge a fee in construct, enlarge, refurbish or remodel a student center on campus. The fee itself can be required by all students attending campus, can charge no more than \$1.00 per credit hour per student – for a maximum of \$10.00 –, and can be pushed if more than 20% of the students enrolled during last election vote yes in favor of the fee. This fee is technically already active, however it is up to the governing board if they wish to proceed. Next, we will discuss the Mandatory Student Activity Fee, which cannot be charged to students due to it being prohibited for students to be charged for events on campus, but will we be discussing it as requested from Dr. Damania. There is no mandatory authority is necessary to charge the fee, as it is technically perishable, however it must be made aware to students so that they may be allowed to decline or accept the fee. This gives the student the option and thus makes the fee legal, despite the controversy around it, it is the student's responsibility to pay or not pay the fee. The closest fee we currently have that relates to this is the KVC sticker, and whether students check or uncheck the box to purchase it. Next on our list of topics to discuss is the appeal process itself. There were talks of installing a telephone oriented appeal process so that students could call and do their appeal process that way, however it was found to be too complex and burdensome. Even our current process for the appeal forms has been noted to be a burden to both students and ourselves, but is the only form of refunding we have. And our final topic of discussion, the Mandatory Student Identification Card Fee, which is another prohibited fee that cannot be charged to students. This includes charging fees to students who lose their ID card, as the district cannot charge replacement fees on ID cards that were originally never charged.
