

## 8. UNFINISHED BUSINESS

Items listed have already been discussed once and thus are considered for approval by the Body

a. Review of the: "Student Fee Handbook" <u>Discussion:</u>

Director Zavala: We will first begin with the discussion of the mandatory student identification card fee, under the guidelines of the fee it is prohibited for the administration to charge students for an I.D. card, however this does not prohibit them from offering I.D. cards for free. We at BC do not charge for the BC I.D., however, if we were allowed to charge, we could offer benefits including discounts at the bookstore and earlier registration dates. Next we will discuss fees charged through student organizations, which states that organizations cannot charge fees through the student body if the student body has no power to levy those fees, also a student organization can charge an optional activity fees so long as they state it is optional to their members, it is stated within their club's constitution and is approved by BCSGA. Next is the provisions on field trips, it states that the District is prohibited from charging students participating in a field trip a fee if its purpose is intended to be used for planning the trip or paying for district equipment, such as gasoline or transportation. However it is permitted to charged students if the money is to be used for food and lodging and other incidental expenses. It is also prohibited for students to be denied from participating in a field trip if they cannot pay a fee, this is true for both required and optional field trips. Only students participating in the field trip can be charged a fee if there is one. Next is the mandatory fee for use of practice rooms, which states that colleges are given the freedom the build practice rooms funded by the students through an optional fee for free reign and use by students; this is separate from a school's facility, which is paid for by the District. Next is the Technology fee, this fee pays for student's use of the internet, email, computer labs and computers. This fee paid for all but 2% of the computers on campus, the remainder can be

charged to students as an optional fee so long as those students are required to use the technology for their courses. However this is prohibited if the district receives state funding. Next we have the Late Payment Fee, which is related to the enrollment fee. The enrollment fee must be paid at the time of enrollment by students, however in the event that it is not paid before students are enrolled, the district is allowed to withhold grades and transcripts from said student. If the student still does not pay their fees, the chancellor's office may charge additional fees. Next is cleaning fees, which state that a flat fee is charged to students who do not keep their chemistry lockers clean. If the locker is damaged, the fee will still be charged, though in most cases students will not be charged regardless; it is optional. Next, breakage fees are

department. The purpose is so that the district can reimburse the money to pay for new replacements. If students ever damage district property on purpose, the district will seek disciplinary action if necessary. And finally, the transportation fee, we have discussed this fee thoroughly as it pertains to the GETBus which may allow students of Bakersfield College to get a free GETBus pass. In order to accomplish this goal,
