The nay's have the majority, and the motion does not pass.

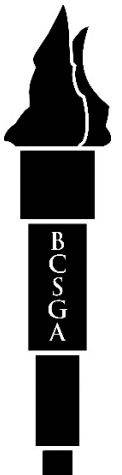
Senator Escobar moved to take a 5 minute recess at 12:40 pm. With no objections the motion was passed.
