b. BCSGA Deans' Liaisons for Committee on Academic Affairs

Discussion: It was expressed that the document amends Title 3, chapter 4, section 3, subsection a. of the COBRA which addresses the minimum and maximum requirements on the number of members that must be on a committee. The reason that Director Lyons was pushing this amendment is for the committee on Academic Affairs to have large amount of Senators on the committee. The committee on Academic Affairs corresponds to 9 deans on campus, and there is a need for Senators to be assigned as a liaison to each one of them. As such, the amendment would have COBRA read "Each committee shall be composed of at least three but not to exceed nine members unless prescribed by the Senate. An exception to shall be the Standing Committee on Academic Affairs which will be composed of at least 7 members". It was expressed that the previous BCSGA session had senators who corresponded to certain deans, or departments, on campus, where the senators would provide a report to Senate. This has been replaced by instead of providing reports to Senate, the reports and issues of students pertaining to academics will be given specifically to Academic Affairs. There was only 2 senators on the committee, and it was clear that there must be more committee members such that each department is equally represented. But it was suggested that the appropriate amendment should be to the charge for the Standing Committee, which is Title 3, chapter 4, section 4, subsection a, item 1, since the change is specifically for that committee to have 7 members, and not changing the general rule of how many members each committee must have.

- c. It was moved by Senator Zavala and seconded by Senator Galvez to table Review of COBRA 101.01 <u>Discussion</u>: It was addressed for the Senators to come into the next meeting with any markups from reading all of Title 1.
 - There were no objections to tabling the item. As such, Review of COBRA 101.01 was tabled.
- d. It was moved by Senator Zavala and seconded by Senator Galvez to table Review of COBRA 202.01 through 202.05

<u>Discussion:</u> It was addressed for the Senators to come into the next meeting with any markups from reading Title 2, sections 1 through 5.

There were no objections to tabling the item. As such, Review of COBRA 101.01 was tabled.
