c. Expansion of Voting during Senate Meetings section

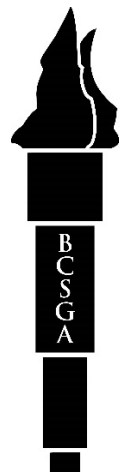
Chair Sharma wants to remind voting members of how their vote counts because they represent the student body. So they should not always use the right to abstain a vote because it affects things to get passed.
