Manager Arias is going to survey students about the power lunches.

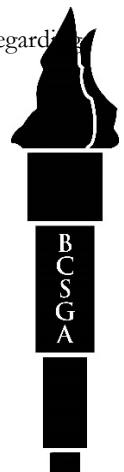
