8. NEW BUSINESS


Items listed in this agenda item have not already been read or discussed once and thus are considered for approval of the committee

center, or within the office, but later decided to implement this idea for the next Homecoming. The posters were already crumpled from the paint and the football game so it'd be harder to accomplish. It was suggested to instead use vinyl paper and sharpies for the next Homecoming.

b. "Halloween Day" on October 29th, 2015.

Discussion: The mummy wrap game is where partners are to wrap each other up full in toilet paper as quickly as possible, and the prize would be a large cotton candy since it seems to be popular. The location of the event will be in between the Health Center and Office of Student Life. The reason for doing so is because in using the campus foyer, music cannot be played in that area. It was also noted that the bulletin boards must be covered or cleaned after because they became very sticky after the last event using cotton candy held in that area. Popcorn will be given out for free, but the cotton candy will be used only as prizes. A volunteer is needed to play music off their phone through the speaker system. The Halloween quotes game would be pieces of paper with scary movie quotes placed on them, and if they guess it right then the contestant wins a cotton candy. Candy will be given out free to all who are dressed up. A sign-up sheet will be placed in the officer for all BCSGA officers to volunteer.

c. Welcome Back Week

<u>Discussion:</u> Ideas proposed by Welcome Back Week were to have the carts to provide rides to students to class, host a movie/music/pop culture game show for groups of students, host a match game where there is a panel of students and the students are to finish clichéd sayings, give out hot chocolate, have a Red & White Day on Thursday, January 21 st where students wear their school colors, give out welcome back school kits of little pouches of basic school supplies like pencils and more, and give out business informational BCSGA cards or goodie bags.

d. Monthly teambuilding event (i.e. volleyball with counselors)

<u>Discussion:</u> There was a consensus among all officers to continue doing sports, or different types, of competitions or contests. The different competitions could be doing Pictionary, or drawing contests, or more beyond sports just to not lose student interest fast. It could be held monthly or bimonthly, but that it could be internal of BCSGA versus BCSGA, or BCSGA versus different departments, or clubs versus departments, and more.

e. Teddy Bear Toss on November 28th.

<u>Discussion:</u> The Director of Student Organizations informed Manager Roberts that the Teddy Bear Toss is going to be involved with the clubs on campus, where the clubs will be collecting the teddy bears and then the clubs will choose BC representatives to go give the bears on the behalf of the school. Additionally, the Condors are willing to give ten tickets, and these tickets will be used as a competition prize for the clubs who bring in the most bears.

9. COMMENTS AND ANNOUNCEMENTS*

- a. Advisor Damania: I was approached this week by Peggy Boyce, the agent for Frank Mink. He does a presentation based on "Former Skinhead Speaks Out", a presentation on racism/hate and upbringing during the white supremacy movement, and Cerro Coso is bringing him out on November 18th. They are looking to come out to Bakersfield College the following day on November 19th, and the cost is \$1500. But I brought this to the committee to see if you would be interested in having this performance. The facilitators from Cerro Coso have said that he is a very good speaker and have actually enjoyed the presentation, and that this is the second or third time they have brought him back. The movie based on him could be shown as well, but the rights to movie would need to be bought in order to show it. An answer to whether or not this presentation should be done needs to be decided at the end of the week. (Committee members expressed concern in that they were not sure what the turnout for the presentation for it would be, and how publicity would work to make sure that word is spread to get classes to attend the meeting. Moreover, it was not secure whether the budget for the Department on Student Activities could afford it. There was a split decision amongst the members as to whether or not go forward with it. Manager Roberts mentioned that she would look into the budget and then ask Senators to see what their take on the event would be.)
- **b.** Manager Roberts: I will have sign-up sheet for the Halloween event to help with cotton candy and popcorn, but also for senators to bring at least one toilet paper roll each.
