b. ACTION ITEM: Approval of allocation of funds not to exceed \$300 from TA-100 student activities for purchase of Orange Juice

# Discussion:

Director Garcia: This orange juice is for our booth on Monday and after crunching some number, the original price of \$100 has been cut down to \$88 after discounts. This will buy approximately 500 bottles of orange juice.

Director Garcia: Yes, any money leftover will go back into our budget and not be used for anything else.

Manager Juarez: Are we buying individual bottles of orange juice?

Director Garcia: Yes.

Senator Van Horne: What does, "TA-100" stand for again?

Manger Juarez: It is our budget account.

Senator Salcido: Everyone who buys a KVC sticker, that money goes into this account, so students are essentially financing their own events.

**c.** ACTION ITEM: Approval of allocation of funds not to exceed 175.00 from TA-100 student activities for the purchase of mechanical pencils in our water bottles

#### Discussion:

Manager Juarez: Do we have an estimate on the number of mechanical pencil we will be receiving?

Director Garcia: I don't have a number at this time.

Manger Juarez: Normally we are supposed to have quotas on these kind of items.

Director Garcia: This was added to the agenda by Dr. Damania.

Senator Van Horne: Is this for a certain event?

Manger Juarez: This is for the Water Bottle event called, "Thirst for Knowledge", we will be stuffing the, with informational materials as well as the mechanical pencils. We will be selling them for \$5, and giving them out for free for KVC card holders.

#### Discussion:

Director Garcia: So we are looking for decorations, as well as planning on buying some stamps for the clubs to hand out to students who visit their booths, once students get 3 stamps total they can get free popcorn or cotton candy.

Senator Salcido: Where will the funds be spent at exactly?

Director Garcia: Right now we have them primarily directed towards buying stamps, which, looking at the price on the agenda, I believe is supposed to be \$50, not \$150. Because stamps don't cost that much, we won't have to use all of the funds.

Senator Salcido moved to re-amend item 8.d. and strike out the price from \$150 to \$50. Seconded by Senator Van Horne

Director Garcia: This item is still open to discussion.

Senator Salcido: What kind of decorations do we plan to buy and from where?

Director Garcia: Right now we wish to but read and black flags from the Dollar Store, but right now we are still planning on buying just stamps.

Senator Van Horne: Which clubs will be in attendance?

Director Garcia: Right I have about 7 clubs sign up, with tomorrow's ICC meeting I hope to get more clubs informed. All the details are on the back for Wednesday, if there is no more discussion the let us move on to roll call vote.

Manager Juarez: The reason I voted no on this is because, quotes are very important, especially right now with us being so close to going over budget.

Senator Van Horne: I agree, since we don't have the budget here with us right now, I don't this this action item is necessary.

Director Garcia: I seems as though the remaining action items are for the second week of events, so I suggest we move the rest of the items for the first week of the fall semester and vote on them then.

Senator Salcido moved to have items 8.d, .e, and .f. moved to our next meeting, pending the retrieval of our budget and quotes. Seconded by Manager Juarez.
