STUDENT EQUITY PLAN

Highlights of the presentation follow:

- 3-year strategies and goals embedded in the Educational Master Plan, Strategic Directions and in line with Accreditation Standards and SSSP
- Must restore access and align with student success indicators; each indicator listed in the plan has overall plan summary and a series of components
- Address disproportionally impacted groups including veterans and foster youth
 - Largest group across all indicators are male students (plan includes strategies to improve success for this group) 45.5 (men) and 53.8 (women)

- Other groups are African American, Hispanic, DSPS, Native American, Pacific Islander, Economically Disadvantaged
- Develop innovative instructional and non-instructional strategies; embed in culture of the college;
- Positions needed to complete the work:
 - o Director of Equity And Inclusion
 - SS Program Manager Equity
 - Manager Of Institutional Research And Reports
 - o Faculty Lead
 - Counselor
 - Translation Services
 - Parent Orientation; how do we work with parents who cannot read? PIQUE in Hispanic community where parents teach other parents; perhaps even bringing them to campus and provide verbal communication; also partnership with FIELD in small communities;
 - Ed Advisor Rural (Delano)
 - o Ed Advisor Equity Program
 - Web Graphic Artist
 - o Digital Media
 - o DAIII
 - Outreach multimedia; Equity TV
 - Peer Mentoring

COLLEGE MISSION STATEMENT REVIEW POLICY

The Standard 1.A Mission Team made the following recommendation for College Council approval:

Mission Statement Policy

Presented to College Council, October 31, 2014

The Standard I.A Mission team recommends that College Council review and reaffirm the Bakersfield College mission statement on an annual basis. On a three-year cycle, we recommend that College Council commission a 'Mission Review Team' to conduct an in-depth study, analysis and review of the current mission statement, along with an assessment of factors (external or internal) that would necessitate revisions to the mission statement.

The following are highlights of the discussion and action of College Council following the recommendation:

- College needs regular and periodic review of mission
- Annual cursory review by College Council as part of the Charter renewal process

- Since we could potentially be selected to be one of the 15 community colleges in the state-wide pilot to offer a BAS, we must review our mission immediately to ensure that the mission accurately reflects this significant change from only offering an associate's degree to now offering a baccalaureate degree as well
- It was noted that that these significant shifts in mission will act as trigger events for College Council to initiate a mission review
- Last review was primarily in response to changes in accreditation standards
- In summary, a more detailed review of the mission should occur within a three-year time span
- A motion was made by Vaughn and seconded by Gomez-Heitzeberg to approve the mission statement policy. It was decided that Pluta, Strobel and Culpepper would develop procedures for College Council to review
