**WELCOME & OVERVIEW of the AGENDA**

Christian reminded Council members of the Participatory Governance Workshop that will begin immediately following the meeting.

Christian made special note of the book, *Redesigning America's Community Colleges*, Bailey, Jagger and Jenkins, and the connection to the Community College Research Center (CCRC) at Columbia College. The book discusses the guided pathways approach to improving student completion. The SSSP Office has ordered 10 copies of the book that can be checked out and there will be chapter discussions facilitated by panelists.

Renegade Promise

Christian reminded the Council that BC started work in 2013 to get students completely through matriculation steps as early as possible, even while still in high school. Now we are focusing on dual enrollment and structured pathways which start in high school to ensure that students complete their two year degree in two years or less. The question is: Can BC, make a guarantee to our community that students will be able to complete a degree or transfer in two years if college-ready and in three years in not yet college-ready.

College Promise:

College Promise is a vision rolled out by the White House that promotes fee tuition for community college students. Last week an independent campaign labeled HeadsUp was launched to raise awareness of this initiative. It will give students, teachers, counselors,

administrators, alumni, businesses, and other leaders a role in spreading the word about the value and impact that universal access to community college will have on our future. Heads Up America will call on everyone to join the movement to make two years of community college free for responsible students around the country. As part of Heads Up America, the College Promise Advisory Board will release a PSA featuring students, community college alumni and celebrities. Learn more at HeadsUpAmerica.us.

### BSI, SSSP, Equity

Christian reviewed the calendar for approval of these categorical plans. Some of the discussion included:

- Original SSSP plan focused on matriculation and funding was used to hire Dean of Student Success, program managers, 5 counselors, and a transcript evaluator
- Additional funds will be used now to focus on follow up services such as tutoring, and supplemental instruction; targeting students on academic probation; looking to expand student workers as ambassadors, mentors and tutors with a robust orientation to strengthen this service
- It was suggested to tie equity and CTE together as CTE focuses on intense case management and was proven successful through C6
- BSI funding will continue to focus on acceleration of pre-collegiate math and English

### Board of Trustees

Since the last College Council meeting on September 4th there has been one Special Board Meeting held on September 17th. In Open session the Board President reported that:

*There was no action taken during closed session. Board has decided that further negotiation is unnecessary and contract will be placed on October agenda.*

## **BUDGET UPDATE**

Budget Compliance Summary

- The document provided provides the 50% law ratio for Bakersfield College. BC was given a target of target 64.9%, but the adopted budget shows the ratio to be 65.4%
- BC has also exceeded the district policy of maintain a minimum 3% reserve; currently the reserve balance is at 9.5%

## **AACC STRUCTURED PATHWAYS**

Christian noted that BC is submitting the application on September 21 and would like College Council approval. Bonds gave the following highlights of the proposal noting the project was not a grant but rather a prestigious award that will involve collaboration with WestEd and the Community College Research Center at Columbia University.

- Project description:
- Building capacity at the college and regional levels for pathways reform; look at area need and develop structured pathways aimed at career and transfer success
- 30 colleges throughout the nation will be selected to comprise 5 person teams
- Pathway Institutes will be offered to help college representatives as professional development

- Proposal is broken down with questions related to student success, data collection, student learning outcomes, completion and transfer outcomes, labor market information, and equity activities
- Proposal shows how BC has institutionalized data through our Renegade Scorecard; reduced the time and cost investment of students needed to complete; embedding pathways work through JP Morgan, CCPT I & II, College Futures, and 1+1+2 =Game Changer
- Proposal interviews will be held in late September with selection determined mid-October. The first Pathway Institute will be held in February 2016

A motion was made by Holmes and seconded by Vaughn to approve the proposal. Vaughn noted the proposal is quite accurate and well-written.
