# In Progress

• Door Hardware Replacement: Vendor is working on 3 buildings at a time. Project will be completed at the end of this month. It will be a culture change on not having door propped open. Panic bars have Velcro to use if the door is to remain unlocked. Doors will be on a software system. There were concerns of hacking into the system. Coordination with all campus to get ID cards. Johnson suggested providing the implementation timeline to department chairs. Collier suggested FLEX training for faculty. Potter stated a video show how the new locks work.

# **Upcoming Projects**

President Christian recognized Bill Potter for his work since the M&O Manager and Department Assistant III positions became vacant.

The campus is failing on energy conservation. Energy use is up to what the consumption was prior to the solar panels. Energy consumption went up 43% in one year.

The Governor is concerned about jobs in California. He has allocated \$200 million to provide training and workforce development. This will be ongoing money for the next 5 years. Kern Community College District Allocation - \$3,850,548.14

- Bakersfield College 60% Local Share = \$1,700,643.96
- Goes to districts to invest in CTE at colleges

- Bakersfield College 40% Regional Shares = \$917,728.77
- Invests in CTE at colleges upon coordination action
- December 2017 New allocation will be based on how well outcomes were met
- Local Share allocations posted August 5, 2016
- Board of Governors approval and Local Share Template went live September 18, 2016
- Local Share funds will be dispersed to Districts October 27, 2016
- Funds can be spent retroactive to July 1, 2016
