Enrollments

The April 19, 2017 report from Institutional Research shows enrollment at BC for summer 2017 is 6.7% lower than the same time last summer although there is a growth of 11.5% of active sections.. A preliminary analysis suggests that there might be a few anomalies with the time of spring break.

College Promise Announcement: April 28, 2017

Many dignitaries will be joining BC at this event. College Council members are encouraged to attend as well.

The Promise focuses on two components:

- Commitment that college ready students are able to complete in 60 units (2 years if attending full time)
- Financial commitment primarily to mitigate costs of textbooks

Outreach Open House: April 28, 2017

- This event will include several hundred high school students with focus on initial matriculation steps. Steve Watkin has asked for administrative, classified and faculty support to staff the event.
- The next It's Possible is May 18.
- Additional efforts in May will target students at each of the high schools.

- Legislation is moving forward to a small group of colleges to be part of a pilot exchange BC is refining its processes and expect to be part of the exchange in the next year or two
- College Council should see that our long term vision is playing out with our investment in the resources to support it—entire programs online
