#### **Enrollment:**

The September 5, 2017 report from Institutional Research shows enrollment at BC for Fall 2017 is 2.0% higher than the same time last fall. That is 137 growth FTES. Our target of 1726 from the 320-IR reconciliation report has our fall 2017 target at 400, spring 2018 at 326 with the summer 2018 at 1000. This shows that we are well below the target. Please inform your students about the two late start mini semesters.
