# Accreditation ISER: Standard IC, Institutional Integrity

Strobel directed the Council the draft document posted to the College Council website and highlighted the components of the Standard as noted below.

- Standard #1: We make sure the information we give is clear, accurate, and truthful.
- Standard #2: We provide a public catalog that meets all ACCJC requirements of published facts, requirements, BC policies and procedures.
- Standard #3: We use public assessments of SLOs and student achievement to tell the public about our academic quality.
- Standard #4: Our programs state their purpose, content, requirements and PLOs.
- Standard #5: We regularly review our policies and procedures and publications to make sure they match our actual practice (that we really do what we say we do).
- Standard #6: We give students the complete picture of their costs of education (every fee and textbooks and materials they'll need for their classes).
- Standard #7: We have broa d policies on academic freedom and we publish and embrace those policies on academic freedom.
- Standard #8: We have clear and easily-accessible policies about academic honesty and academic integrity that includes what happens if someone violates those policies.
- Standard #9: We exercise academic freedom responsibly to encourage objective investigations of different points of view.
- Standard #10: We publish our codes of conduct for all employees and students so they are conveniently accessible, including in the catalog and student handbook.
- Standard #11: Colleges in foreign countries still must follow ACCJC standards and policies.
- Standard #12: We agree to do what ACCJC requires and give ACCJC the information it needs to accredit us.

- Standard #13: We demonstrate honest relationships with our external agency partners. We give accurate information about our accreditation status.
- Standard #14: We make sure that high-quality education, student achievement and student learning is our top priorities above anything else


- Reviewed 109 programs this year, and include the first baccalaureate program review
  - o Three-year summary:
    - 2015 98 programs 87% submitted
    - 2016 108 programs -96% submitted
    - 2017 112 programs 97% submitted

The Program Review Committee will focus on assessing received resources; improving assessment forms customized for administrative units, and aligning with Guided Pathways.
