Welcome and Overview of Agenda

Christian welcomes new College Council members and guests.

Approval of Minutes

Council members reviewed the minutes of May 3, 2019. Dadabhoy motioned and Ono seconded to approve the minutes as presented. The Council approved the minutes.

May 3, 2019

President's Report

Christian directed the Council to the posted report and highlighted the following items:

- Inmate Scholar agenda item: Brant Choate, Director, Division of Rehabilitation Program, initiated a visit to BC to learn about the Industrial Automation bacalaureate program, and will also join College Council later in the meeting.
- Budget:
 - with the implementation of the Student Centered Funding Formula, BC is focused on strategic fiscal planning to continue serving our students
 - hiring management and classified are currently on hold; faculty positions have been filled
- College Promise: Kern Promise is focused on completion, providing support that removes barriers allowing students to complete more efficiently. In California the Board of Governors (BOG) Waiver is now referred to as the College Promise and addresses finances for students directly.
- Guided Pathways is embedded in the college operational structure
- Institutional Planning: three plans will sunset in the coming year. Teams will be established to review and update the Educational Master Plan, the Technology Plan, and the Facilities Master Plan.
 - The following institutional plans are up for review.
 - Educational Master Plan (2020-2023)
 - Technology Master Plan (2020-2023)
 - Facilities Master Plan (2020 update)
- Bakersfield College received the John W. Rice award for the Equity

Systematic Approach to Workplans, Program Review and Resource Allocation

Rice directed the Council to the Administrative Council website. Rice noted the workplans are a result of the management summer retreats, intentional reflecting from the past year and strategic planning for the next year so our work is stronger. This work focused on meeting the mission, streamlining processes, and strategic budget and enrollment management. The administrative workplans align from the President's vision to the operational details focused on momentum points.

College Council members are encouraged to review and engage in the workplans.

Facilities Update - Solar

Giacomini directed the Council to the materials posted to the website, and reviewed BC's Renewable Energy Strategy noting the following components:

 - 2,000 kW Solar Parking Canopies
 - 583 kW Ground Mount
 - o 75% Energy Offset
- Battery Storage
 - o 750 kW system
 - o Demand Shaving
- Save
- +\$2.7 million over 20 years
 - o PPA: 0% Escalation
- DSA Pre-Check Design
- Timing: As early as 2020 Q2

BCSW Update

Wojtysiak provided a brief update on the new BC Southwest site: Opening Day presentation

- Current enrollment is 360 FTES; additional late start classes will be added
- Construction should be done by October 8th, when furniture and technology will be moved in
- Classes are expected to begin at the new site on October 21st
- Expanding student services including a dedicated counselor, admissions and library services

AIQ Report

Wojtysiak provided an update on Accreditation & Institutional Quality Committee work, noting the annual evaluation of college services through the Annual Satisfaction Survey. The committee is also reviewing the Institutional Set Standards and will bring to College Council at a later date.
