A. Co-Chair Reports

- 1. Billie Jo Rice stated there was a curriculum regional meeting in Long Beach and it was discussed that "these are historical times". Everyone is frustrated. If we are not in compliance by the end of the spring, the college loses funding. Five to six years ago, constituents went to their state representatives and complained about the community college and transferable courses. The legislature made laws but the community colleges did not do anything. The legislature has made stronger laws tying ADT's with college funding. There is only one other college that needs 16 ADT's.
- 2. John Carpenter stated for assessment, the student learning objectives and C-ID objectives were different.
- 3. Curricunet issues: We are getting ready to transition to META. They are making changes to curricunet and not informing us. If you see something different in c-net, please let us know. It seems like every time we go to do something, something has changed. It is very frustrating. Remember to use Firefox as the internet browser for c-net.

- A. On-going training Curricunet Approval queues
 - 1. When you submit a course in c-net, it goes to the approval queue as "launched". You are locked out of making changes while the course is in approval queue level 2 department head and dean. If they request changes, the course moves back to level 1 originator and changes can be made by the originator only not the co-contributors. If the course is not in the approval queue call Billie Jo or John to "find" the course. Please save attached files as PDF's as they upload faster.

B. High Unit Course Justification

- 1. Nick Strobel submitted changes to the form. Departments need to be more strategic about course offerings. Some departments are mapping out a two year plan to achieve an ADT. Students will need a plan to follow. There is a student ed plan template in degree works. Nick has made a matrix of courses that satisfied all three gen ed plans: BC, CSU GE, and IGETC. The matrix is out of date and will need to be updated. It is confusing to map out a plan that meets all three GE requirements. Ed plans would allow degree works to see how many students want to take specific courses.
- 2. It is proposed that all courses over the C-ID minimum will need to complete a high unit course justification sheet for committee review. The curriculum committee will vote. There is a concern that if colleges do not start addressing high unit courses, the state legislature will mandate changes. We have access to data for all 112 community colleges.
- 3. At BC, the CSU GE is 41 (not 39). Think about the unit counts and go back to your departments and discuss. Please provide feedback from your departments. Courses that have high units are mostly in the "B" areas, and MATH B22 and ENGL B1A. For example, those two courses bring the BC CSU GE pattern to over 39 units.
