HIST B9 discussion - 20 minutes:

Discussion occurred with four main segments: those in support, neutral, in opposition and open discussion.

Support: The Social Science department expressed concern about process changes, different standards for this course, and expectations of comparable courses. The department has made modifications and will entertain a friendly amendment to modify more of the areas of concern.

Neutral: A member at large noted that a better research method for evaluating the effectiveness of critical thinking courses was proposed. The use of an objective 6-year evaluation for all critical thinking courses, including HIST B9, was suggested. After which, GE designation would be revisited, for all courses.

Opposed: The English department representative felt the history course was too specific and that there are other courses that meet that area.

The Philosophy department representative said the team tried to be objective. He doesn't think History fits the criteria of Title 5 analytical thinking.

The Communication department representative said the GE team did nothing different for HIST B9. He noted that the course is requesting IGETC and not CSU GE. He said there is no evidence that this course will improve critical thinking ability. He asked the committee to consider student impact.

Open Discussion:

Clarification of process - If a course has overlooked a CSU area, the committee can enter it as a friendly amendment. It has been done before.

The Social Science department said they took the recommendations from the GE team seriously. They were asked for materials to be in the outline even though they were already in the objectives. No other course has been required to provide statistical evidence. The department said they would be make more changes if requested.

Multiple committee members suggested the committee entertain a friendly amendment.

Curriculum Co-Chair suggested a vote for IGETC 1B with a friendly amendment this meeting and then CSU A3 at a later meeting. The friendly amendment will be that the history department will update/respond to all of the requested changes: critical thinking assignment, updated outline, additional textbook, research project with application and historical methodology.

The GE team will review CSU A3 before next meeting.

November 14th is the last meeting to get course approved for the catalog. November 21st meeting will probably be short and just for voting.
