10.A. Assembly Bills (Kennedy/Menchaca)-Keri and Erica reviewed the new Bills, AB 927 the Baccalaureate program. AB 1460 Ethnic studies we are going to wait until next year. AB 928 Single GE pathway for transfer to start 2025. AB 1111 Common course numbering by summer 2024. May use C-ID as a starting point. AB 705 Student success act. AB 1705 is newly introduced. They are posted to the Curriculum Canvas website.

10.B. BC Equitable Placement (Sooyeon/Hayward)-Data addendum. Improvement Plan. In 2019 BC submitted a plan, it was found we did not meet the throughput requirements set by the state. BC has to now defend enrollment in non-transfer courses. Craig will share his document when he finalizes/cleans it up.
