**CSU GE and IGETC 2022 Guiding Notes:** New [CSU and UC Guiding Notes for General Education Course](#) Review have been published. They are on the Curriculum Committee webpage.

**GE Proposals:** New Title 5 proposals will include a Local General Education Proposal at 21 units and separate but aligned local Bachelor's Degree Program General Education Proposal at 27 units with option to add Lifelong Learning and Language other than English. **ASSIST Deadlines:** Curriculum updates effective Fall should be published by May 15, Spring by November 15, and Summer by February 15. Board of Trustees (BOT) approval must be granted before courses can be entered into ASSIST for publication.
