

NOTICE OF PROPOSED RULEMAKING CALIFORNIA CODE OF REGULATIONS, TITLE 5, REGARDING RISING SCHOLARS NETWORK REGULATIONS

45-Day Notice published March 10, 2023

NOTICE IS HEREBY GIVEN, pursuant to Chapter 2 of the California Community Colleges Board of Governors (Board) Procedures and Standing Orders, that the Board proposes to adopt the regulatory action described below after a public hearing, and considering all comments, objections, or recommendations received regarding the proposed action during the public comment period.

PUBLIC HEARING

A public hearing will be held during the next regularly scheduled Board of Governors meeting on March 20, 2023. The March 20, 2023 Board of Governors meeting will be held in a hybrid format. Members of the public may participate in-person or via Zoom videoconferencing.

Public Comment Submission Process

Public Comment: Members of the public wishing to comment on an agenda item or another topic within the jurisdiction of the Board of Governors will be given the opportunity to comment via Zoom or in-person at the location listed above. For any questions, please contact the board liaison at ccastro@ccco.edu. All comments will be limited to two minutes and the following policies:

- 1. In-person with a written request to address the Board shall be made on the form provided by staff at the meeting. Persons wishing to address the Board on a subject not on the agenda shall address the Board during the time listed for public forum.
- 2. Virtual attendees may use the Raise Hand feature on the Zoom platform to address the Board. A Chancellor's Office employee will announce your name and grant you the ability to speak. You are requested to identify yourself and present your public comment at that time. Persons wishing to address the Board on a subject not on the agenda shall address the Board during the time listed for public forum.
 - The Board of Governors reserves the right to limit the total amount of time allocated for public comment on particular issues and for each individual speaker. (Gov. Code 11125.7.)
 - For members of the public utilizing a translator or other translating technology, the Chancellor's Office shall provide twice the allotted time to ensure that non-English speakers receive the same opportunity to directly address the Board. (Gov. Code 11125.7.)

CHANGES OR MODIFICATIONS TO PROPOSED TITLE 5 AMENDMENTS

Following the public hearing and considering all timely and relevant comments received, the Board of Governors may adopt the proposed regulatory action substantially as described in this Notice or may modify the proposed regulatory action if the modifications are sufficiently related to the original text. With the exception of technical or grammatical changes, the full text of any modified proposed regulatory action will be available for 15 days prior to its adoption, and will be provided to those persons who have requested or are required to receive notification of regulatory actions, or who have provided written or oral comments relevant to the proposed regulatory action.

INFORMATIVE DIGEST

Assembly Bill 417 (2021) authorized the Chancellor's Office to establish the Rising Scholars Network as a new categorical program. It authorizes the Chancellor's Office to enter into agreements with up to 50 community colleges to provide additional funds for services in support of postsecondary education for justice-involved students. The bill defines "justice-involved" as a person who is currently or formerly incarcerated in a California correctional facility, or currently or formerly detained in a juvenile facility. Funds allocated for the Rising Scholars Network should be used to expand the number of justice-involved students participating and succeeding in the community colleges and to be used, to the maximum extent feasible, for supports and services, including, but not limited to, providing specified programs to justice-involved students, such as academic counseling or advising, academic tutoring, or financial aid information and application assistance, peer-to-peer support or mentoring, and assistance with accessing campus resources, including admissions, financial aid and student services.

AB 417 also required the Board of Governors to adopt regulations for the Rising Scholars Network implementing the purposes of the statute. This regulatory action fulfills that requirement.

ESTIMATED COST OR SAVINGS OF PROPOSED AMENDMENTS

The proposed regulatory action merely implements statutory requirements that authorize community college district participation in a grant program. Accordingly, the estimated cost or savings attributable to the proposed regulatory action are anticipated to be as follows:

Mandate on local agencies or community college districts: *None*.

Cost or savings to state agencies: None.

Costs to local agencies or community college districts for which reimbursement would be required pursuant to part 7 (commencing with section 17500) of division 4 title 2 of the Government Code: *None*.

Other non-discretionary cost or savings imposed on community college districts: None.

Cost or savings in federal funding to state agencies: None.

The proposed amendments to title 5 would result in no fiscal impact to local or state governments, nor will it have any fiscal impact on any federal funding. As a grant-based program, the colleges wishing to serve justice-involved students through participation in the Rising Scholars Network, apply for a portion of the funds appropriated for this purpose, thus voluntarily incurring the duties and obligations imposed under these regulations. Moreover, the relevant statutes provide that the program shall be operative in a fiscal year only if funds have been appropriated for that purpose for that fiscal year by the Legislature.
